Chicago Chapter News

Those of us with the Chicago Chapter who gathered on February 19 felt sorry for Louise Austin because we could not provide her with a blizzard or ice storm to drive through from Wisconsin this year. It was no challenge at all, really, sunshine, 40 degrees or so, quite unlike other February meetings in this odd winter of 2012. So all we could do was to enjoy playing recorder together, and Louise has been quite skilled at managing that, regardless of climate trends.

Louise started by offering some traditional Welsh melodies arranged for recorder by Alyson Lewin, with

names like *Hela'r Ysgyfarnag* and *Bugeilio'r Gwenith*. "This to me is a prime example of good contemporary recorder music," Louise said.

The Baron's Noyse provided variations on two themes, *A Solis Ortus* and *Browning, my Dear* (or "The Leaves be Green"). Some 20 different variations on the popular tune of *Browning My Dear* exist from the 16th century.

A solis ortus cardine is a poem written by the 5th century Italian philosopher and cleric Coelius Sedulius, narrating the life of Christ with each line starting with the next letter of the Latin alphabet. The poem was used in the Middle Ages and Renaissance as a hymn, also with many versions produced. Martin Luther translated the text into German in 1524, and added it to his published collection of Protestant hymns.

A Letter to the Editor

Nancy Chabala contacted Dennis Sherman to reflect on some issues facing the Chicago chapter. We print her email here as requested, and Dennis' response.

I have a number of points that I would like to make concerning the Bylaws and a change of venue for May.

<u>First point</u>: Your link to review the bylaws cannot be viewed unless you are member of/or join Yahoo-which I don't plan on doing.

<u>Second</u>: You still speak of changing the terms to one year when they've always been one year.

<u>Third</u>: Succession was never a goal, it just was what happened because of too few candidates and people who were willing to hang around on the board for years Maybe if people knew they only had to serve for one year you'd interest a few more. You don't have to change a thing, unless it is to drop 2nd VP.

<u>Fourth</u>: Most board meetings should be held at the start of a monthly meeting so that all can be involved.

<u>Fifth</u>: On the change of venue for May - You forgot to mention the price for this venue, I believe \$180. The board can't just go willy-nilly spending money without a vote from the membership, especially when there will likely be no benefit from the expense. Maybe we should try to get more of our own members to show up at our venue (in November less than 10 and 5 of us were performing, in January, 9, and 2 performed) before we spend money on people who just might want to listen.

<u>Sixth</u>: It does not make good sense to move a venue. People who don't normally pay attention to newsletters will remember "Third Sunday at Covenant." They show up and we're not there. Not good.

<u>Seventh</u>: This one is to me the reason I will not be there if the venue is changed. Those of us who are not in good health don't wish to have to wander around searching out a parking space, trek a block or more and navigate stairs while carrying instruments and stuff. It is just not worth it to me. The walk from the lot and the stairs are all I want to handle. It is short enough that I can make more than one trip if necessary.

I've been a Chicago Chapter member for almost 40 years and served on the Board for around 10. I know that I am only one person and others won't share my opinion, so thanks for letting me express them.

Hi Nancy,

Thanks for your thoughts. I appreciate hearing them.

My opinion is that on a careful reading of the bylaws you'll see that there is more that should be changed than just dropping the second VP, but I'll leave that to you to decide. Having an alternative delivery method other than Yahoo is a good idea. Anyone interested should just email me, and I'll send them a copy.

Nothing is a done deal as far as changing venue, and the more opinions we hear the better the final decision will be for all concerned. We're looking at ways to find and draw new members, and this is one possibility. The cost of the venue was not forgotten, it was left out intentionally. We have too many members that have an automatic "no" reaction to anything that costs money, and should we decide to use this venue, there are some options to cover the cost that don't involve the chapter's funds. The cost of the venue should be a separate discussion from the idea of changing venues, and there's no point in having it if we decide not to pursue moving the recital.

I suspect that there are other people who will share at least some of your opinions, and you taking the time to express them may help them to come forward. Thank you.

The company found demand for tickets so high that they added a third performance. The Company seeks to offer historically accurate performances of 17th and 18th century operas for Chicago audiences, specializing in the Age of Reason

and the Enlightenment. "The board of directors, donors, and volunteers of HOC believe that the company will become a cultural gem of the city and region. HOC seeks to engage audiences of all ages with passionate performances of familiar as well as forgotten works."

Ellen Hargis, the Stage Director, is a soprano with the Newberry Consort.
